*History of Disabilities* demonstrates how society has presented and treated individuals with disabilities historically. Materials in the inaugural collection in this series include records of treatments, methods of education, forms of remediation, and more. Reports and proceedings of organizations and institutions that sought to help or heal those with disabilities are included, as well as records of policies and programs. Through this collection, researchers will grasp the many forms of institutional discrimination, political exclusion, and social control under which those who were identified as disabled struggled. The collection chronicles how individuals were classified and treated—and how some overcame physical or mental challenges to defy perceptions of being disabled.

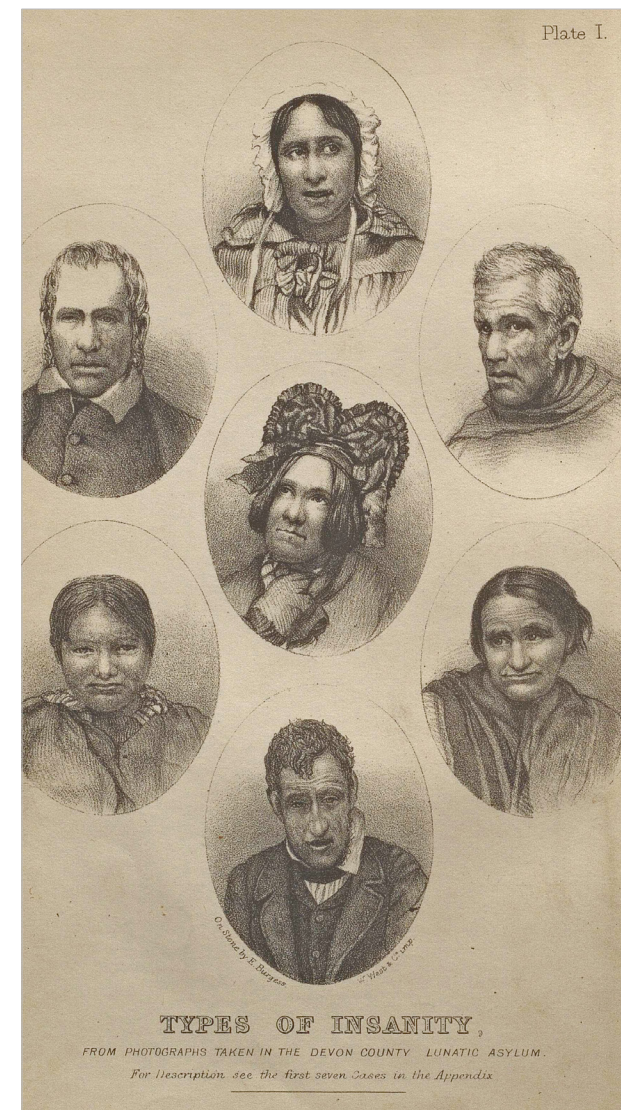

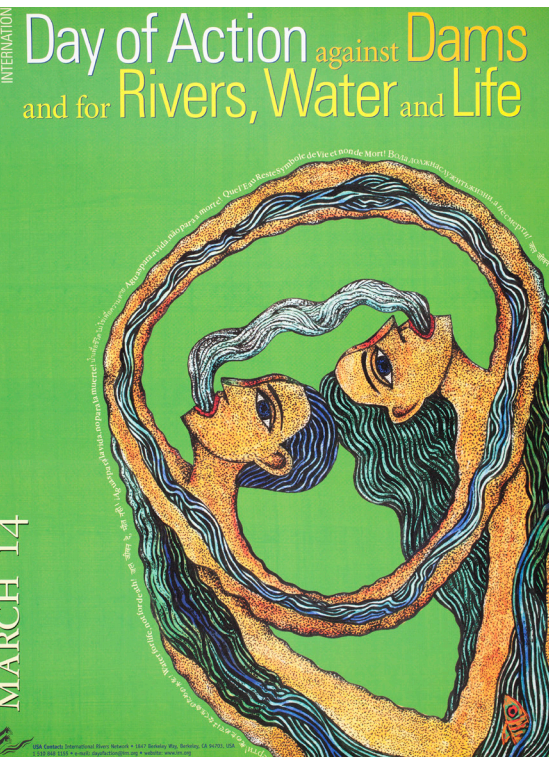
### VALUE OF THE ARCHIVE

## POWER TO THE PEOPLE: COUNTERCULTURE, SOCIAL MOVEMENTS, AND THE ALTERNATIVE PRESS, NINETEENTH TO TWENTY-FIRST CENTURY

*Power to the People* showcases a range of ideas, initiatives, and social movements devoted to people-powered politics and organizing from the nineteenth through the twenty-first centuries. Ranging beyond a few specific movements, the archive paints a broad picture of the counterculture and many disparate organizations that represent this moment in modern Western history.

Through the primary sources in this collection, researchers will discover how social justice issues and attitudes about civil rights, gender equality, the environment, the government, and many of society's institutions shifted dramatically to include citizen involvement, public welfare, and the planet's health in the twentieth century. Although the archive concentrates mainly on the United States and the United Kingdom, it also covers events and topics from around the globe.

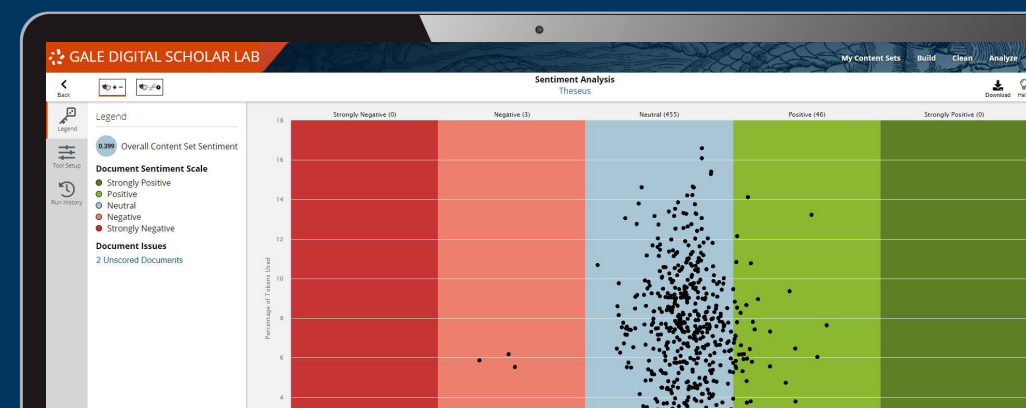

# UNDERSTAND THE ROOTS OF THE ENVIRONMENTAL CONSERVATION MOVEMENT

There are many meaningful causes motivating today's college students, but climate change and environmental conservation are at the top of the list. Engage your students' passions and help them better understand modern-day climate change debates by examining humanity's impact on the natural environment through 100 years of environmental history.

Offer an impressive collection of primary source material for students to explore the U.S. conservation movement with *Environmental History: Conservation and Public Policy in America, 1870–1980*. From the Industrial Revolution to the dawn of the Reagan era, provide context for how history shapes modern environmental decision-making and governmental policies. The *Environmental History* archives are your road map to help students trace the roots of the climate crisis; show how individuals have successfully sought to fix it; and inspire the next generation of activists, climate scientists, and decision-makers.

## RECOGNIZE MAJOR MILESTONES & EARLY CONSERVATION HEROES

For generations, people have valued and fought for environmental conservation, providing hope for the present moment. Today, we have celebrity activists like Greta Thunberg, vegan recipes shared via social media, and selfies in stunning national parks. Modern environmental conservation is trendy and accessible, but how did early conservationists raise awareness?

Turning to the *Environmental History* archives, start with Yale University's George Bird Grinnell Papers, 1886–1939, a fascinating collection of records from the Father of American Conservation, who helped found the National Parks Association. Comb through the *United States Bureau of Land Management Records, 1944–1979* for files detailing efforts to establish environmental protections while managing the needs of an expanding population. Find environmental impact statements mandated by Nixon's National Environmental Policy Act and discover speeches from the 1960s imploring people to live differently and opt for alternative fuel sources, specifically moving away from coal and toward gas.

Researchers can explore primary source materials from diverse repositories, including digital collections featuring the endeavors of early conservationists like Velma Johnston's efforts throughout the 1950s to protect wild horses and Roger Wolcott Toll's work establishing national parks in the early twentieth century. By delving into the Gale archives, your students can recognize the similarities between environmental conservation efforts in the past and today.

## THINK CRITICALLY ABOUT MODERN-DAY ENVIRONMENTAL DISCUSSION

Today's environmentalists, scholars, and industry leaders debate strategies to reduce fossil fuel usage, the ethics of nuclear power, and the efficacy of electric vehicles. Connect researchers to *Environmental History* collections that provide models for collaboration between government agencies, businesses, and activist organizations.

For example, researchers can find reports detailing the country's early efforts to regulate natural resource protections in the *United States Forest Service Collection, 1870–1981*, including trespass logs that illustrate the agency's struggle to enforce its authority against business interests—a common theme in today's environmental conflicts. Or students can dive into the Rosalie Edge Papers, 1930–1954 to follow the story of Rosalie Edge, an environmental activist and equal rights campaigner in the women's suffrage movement who called out corruption in male-dominated environmental organizations. Stories like hers encourage students to think critically about the intersection between environmental conservation and social justice issues today—and how fighting for one elevates the other.

We can only make progress if we learn from the past. Provide students with valuable insight into the country's ongoing conservation movement and a path forward for viable solutions with the new *Environmental History* collection.

## ENVIRONMENTAL HISTORY: CONSERVATION AND PUBLIC POLICY IN AMERICA, 1870–1980

Starting in the late nineteenth century, in direct response to the late Industrial Revolution, forces in social and political spheres struggled to balance the good of the public and the planet against the economic exploitation of resources. A long history lies behind these contests that join advocacy to action, and pit public policy against human behavior, giving rise to local legislation and international trade rules—a history framed by the rise of the modern conservation movement.

This diverse inaugural collection in Gale's new *Environmental History* series offers a glimpse into the many actors and agencies whose efforts shaped modern policy and legislation in conservation and environmental protection in the United States. Researchers will find the work of individual movers and shakers, such as early environmentalists George Bird Grinnell and “father of forestry” Joseph Trimble Rothrock, as well as later activists like Rosalie Edge and Velma “Wild Horse Annie” Johnston. They can sift through the records of agencies such as the United States Forest Service and the U.S. Bureau of Reclamation, as well as the many departments focused on conservation and land-use matters.

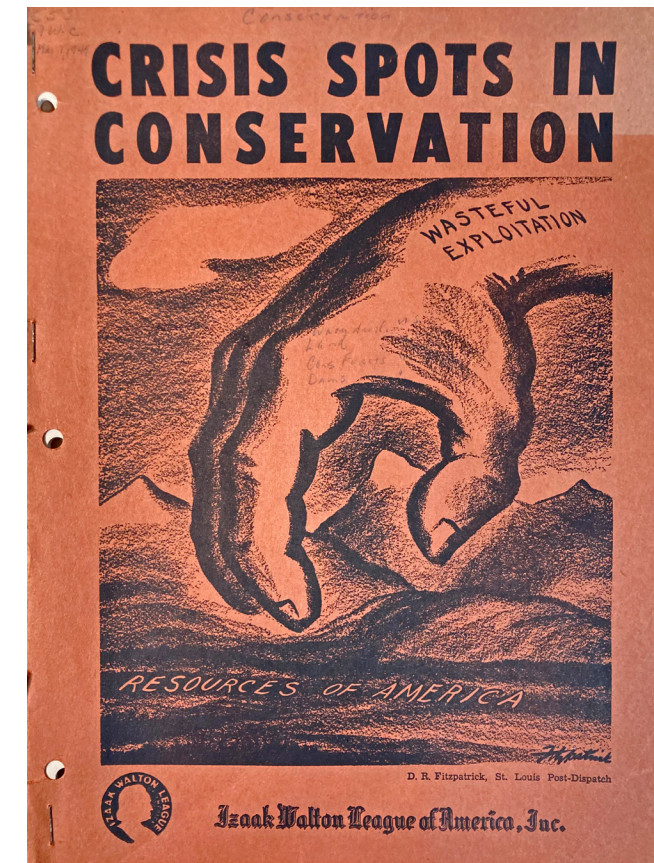

## LGBTQ HISTORY AND CULTURE SINCE 1940, PART II

The installment adds greater depth and context to the *Archives of Sexuality and Gender* series, shedding light on the hidden histories of underrepresented groups. Content sources such as the ONE National Gay and Lesbian Archives and the Canadian Lesbian and Gay Archives provide a unique and international selection of periodicals, organizational papers, manuscripts, posters, correspondence, pamphlets, and more.

## SEX AND SEXUALITY, SIXTEENTH TO TWENTIETH CENTURY

This archive features more than 1 million pages of content that had long been limited to restricted access. Comprising more than 5,500 rare and unique books covering sex, sexuality, and gender issues, it examines patterns of fertility and sexual practice; prostitution, religion, and sexuality; the medical and legal construction of sexualities; and the rise of sexology. The collection covers a wide range of previously taboo topics and provides context to the first two collections in the series, with unique perspectives on history, society, social mores, and changing views of sexuality.

## INTERNATIONAL PERSPECTIVES ON LGBTQ ACTIVISM AND CULTURE

This collection examines diversity in underrepresented areas of the world, such as southern Africa and Australia, highlighting cultural and social histories, struggles for rights and freedoms, explorations of sexuality, organizations and key figures in LGBTQ history, and countering the erasure of the stories and experiences of LGBTQ people from official histories.

## L'ENFER DE LA BIBLIOTHÈQUE NATIONALE DE FRANCE

L'Enfer (hell), from the Bibliothèque Nationale de France, is one of the most storied and sought-after private case collections. The collection was created in the 1830s to protect and isolate works considered contrary to the morals of the time. As with later private cases, the entire collection was kept in a locked section of the library until recently. *L'Enfer* actually refers to the shelf mark given to the collection. While many of the books were consigned to the collection as morally reprehensible, it is to our benefit today, as they were safeguarded for posterity.

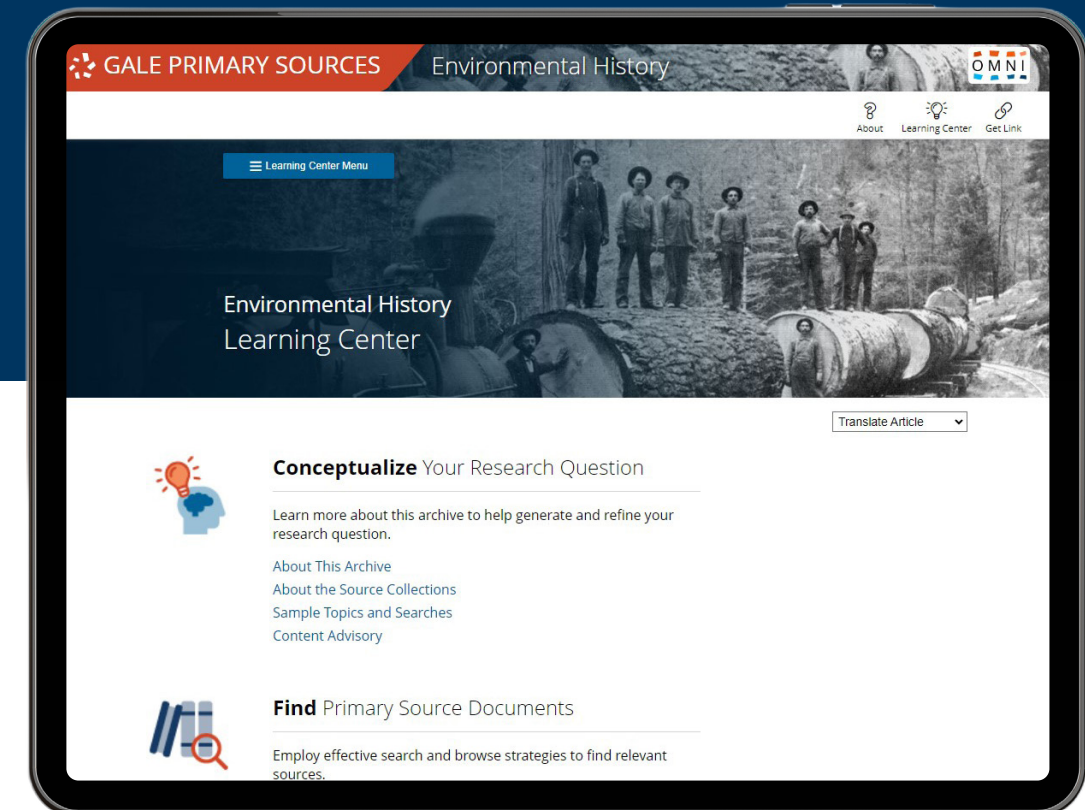

### ABOUT THE COVER IMAGE

This is a painting by Louis Wain, the visual artist known for his many vibrant drawings of cats, which earned him some renown in pre-World War I England. He was certified "insane" in the 1920s, and, shortly following his death in 1939, a psychiatrist named Walter Maclay came across a handful of cat drawings that Wain made after he had been committed. This artwork had a noticeably different character from the cat figures he had been known for, and Maclay took them, without supporting evidence, to show the progression of Wain's mental decline into what he supposed to be schizophrenia. This collection and Maclay's theory about them became known as "Kaleidoscopic Cats," and for decades it stood, within both the medical and artistic communities, as documentation of an artist in a deepening state of psychosis. More recently, however, it's been proposed that these drawings, progressively less literal and more pattern-focused than his earlier work, in fact convey the strengthening of an artist's talent—a broadening of horizons as opposed to the receding of a rational mind. Wain's life and art were later memorialized in books as well as the feature film *The Electrical Life of Louis Wain*. The drawings are just one of the visual collections within the *Gale Primary Sources* archive *History of Disabilities: Disabilities in Society, Seventeenth to Twentieth Century*, which, among other themes, shows how mental and physical ailments were perceived over time.
